- a) Curriculum and Instructions Update Amplify (SO) Oral update Amplify materials by Mr. Terry: K-2 has the hard cover teacher books, but no student books; 3-5 has trade books; 6-8 received the student books; missing hard cover teacher books, but has access to online version
- b) Statewide Test Scores Update (SO) –Kelly Haile provided an update to school staff at the Friday meeting; Mr. Terry highlighted the changes in the procedure and interpretation of test scores/results to council.
