

AUTHORIZATION FOR CAFETERIA CHARGES

The foodservice unit of the Anchorage Public School offers parents the opportunity to allow their children to charge items in the lunchroom. We require parental authorization to charge up to a maximum of one hundred dollars (\$100) per child with the understanding that charges will be repaid in full prior to the end of the school year and that **finance charges will accrue on outstanding balances**. Also, as a service, parents can place pre-payments on their child's account, which their children can charge for purchased items.

Parents must authorize charges yearly by completing the following and returning it to Mackenzie Bartley, Director of Foodservice at Anchorage School. This must be completed and on file before making the initial charge.
